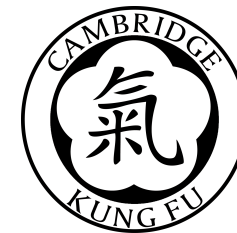

General Information About the Activity:

Students in the classes are normally aged 11-16 however some exceptions may be made if students meet an acceptable standard (in terms of maturity and ability) or if they wish to complete the syllabus some students stay in the Youth class post 16 up to the age of 18. Students train in Martial Arts and play Martial Arts games both of which may involve contact between the students and/or Instructors. During the classes Mats, Rubber Spots, Cones, Yoga Balls, Dodgeballs, Pool Noodles, Padded Sticks, Padded Whackers, Boxing Gloves, Focus Pads, Kick Shields, Shin Pads and Training Weapons (e.g. non sharp sticks & knives) may be used (and other equipment as necessary). Each class has one Lead Instructor with as many additional Assistant Instructors as needed to ensure effective running of the class.
